Premium **Hand Cleaner** for effortless removal of extreme soiling such as paints, colours, adhesives, oils, etc.

With natural abrasives made from walnut shell meal.

PROPERTIES

PEVA PREMIUM is designed to efficiently remove extreme contaminations such as lacquers (2-component varnish), paints, glues, polyurethane foams, resins (epoxy resin), floor sealant, but also oil, grease, lubricants, etc.

- ✓ unites excellent cleaning performance with, at the same time, very good skin tolerance.
- ✓ suitable for use in various areas of work that might cause the above mentioned contaminations.

COMPOSITION

PEVA PREMIUM is made using selected special raw materials.

- contains environmentally-neutral and skin-gentle ester oils to support cleaning.
- contains finely ground and rounded walnut shell meal as abrasive. Walnut shells are a waste product, so that there is no competition with food.
- walnut shell meal does not clog any drains.
- contains coconut oil components and another plant-based moisturising component to ensure skin feels good after washing.
- is free of silicones.
- is dermatologically tested with the rating of "very good".

APPLICATION

Rub **PEVA PREMIUM** into dirty, dry hands until the dirt dissolves. Add some water, wash thoroughly and rinse well.

PEVA PREMIUM is economical in use. One dispenser dosage quantity is sufficient for thorough manual cleaning.

Note: Avoid contact with plastics. If it comes to contact with eyes, flush with large amounts of water
