# PROPERTIES

**PEVALIN WIPES** effectively remove stubborn soiling such as paints, varnishes, oils, grease, bitumen, tar, PU foams, adhesives, resins, etc., and are particularly suitable for mobile working at sites where water is not available

# APPLICATION

Take a moist **PEVALIN WIPES** cloth from the bucket dispenser and rub it into soiled, dry hands. Continue rubbing the skin until all the soiling has been removed. No rinsing required. Dispose off used wipes with the household waste. Do not discard in the environment or flush down the toilet.

Note: Avoid contact with plastics and painted surfaces. Do not use for facial cleansing!

## **PRODUCT DESCRIPTION**

**PEVALIN WIPES** are moist, scented cleansing wipes. pH value: approx. 4.8 – 6.2

#### **STORAGE INFORMATION**

**PEVALIN WIPES** have a shelf life of 3 months after opening.

#### **SKIN CARE TIPS**

When handling harmful substances, a suitable skin protection agent should be used to prevent skin damage before starting work (e.g. the generally applicable skin protection lotion **PEVAPERM**).

After finishing work, a suitable skin care product should be applied regularly (e.g. **PEVALIND**, the active substance-rich skin care lotion) to regenerate the skin.
