## PROPERTIES

**PEVACLEAN** SENSITIVE is an especially mild Hand Washing Cream designed for the sensitive removal of medium to heavy soiling (such as oils, fats, dust) from the skin when traditional abrasive products are not desired.

- effectively cleans even heavier dirt and is extremely gentle on the skin due to a high content of re-fattening substances.

## COMPOSITION

**PEVACLEAN** SENSITIVE consists of selected, high-quality raw materials, which are to a large extent of plant origin.

- contains hardly noticeable, ultra-fine Tiny-Pearls made from plant-based carnauba wax, which gently remove dirt.
- the carnauba wax pearls come from sustainable fair-trade cultivation and do not clog drains.

## APPLICATION

Gently rub **PEVACLEAN** SENSITIVE into dirty, dry hands until the dirt dissolves. Add some water, wash thoroughly and rinse well.

Note: Avoid contact with the eyes. In case of eye contact, immediately rinse thoroughly with plenty of water.

**PEVACLEAN** SENSITIVE is a flowable, white to pale yellow hand washing cream, unscented. pH-value: approx. 5.0 - 5.5 Density: approx. 0.90 g/cm<sup>3</sup> (20°C)

## **STORAGE INFORMATION**

**PEVACELAN** SENSITIVE can be stored in closed original containers at room temperature for at least 24 months.

#### **SKIN CARE TIPS**

When handling harmful substances, a suitable skin protection agent should be used to prevent skin damage before starting work (e. g. the generally applicable skin protection lotion **PEVAPERM** PURE).

After work, a suitable skin care product should be applied regularly onto the skin (e. g. **PEVALIND** PURE, the active substancerich skin care lotion) to regenerate the skin.
